KEY PERIODS AND THEMES IN WORLD HISTORY

THE MEDIEVAL WORLD AND THE SPREAD OF RELIGIONS

THE RENAISSANCE AND THE AGE OF EXPLORATION

THIS INCLUDES UNDERSTANDING THE MOTIVATIONS FOR EXPLORATION, THE TECHNOLOGIES THAT ENABLED IT, AND ITS IMPACT ON INDIGENOUS POPULATIONS.

THE REFORMATION AND THE RISE OF NATION-STATES

THE RELIGIOUS AND POLITICAL UPHEAVALS OF THE REFORMATION ARE A CRITICAL FOCUS, EXAMINING THE CHALLENGES TO THE CATHOLIC CHURCH POSED BY FIGURES LIKE MARTIN LUTHER AND JOHN CALVIN. THE ENLIGHTENMENT AND THE AGE OF REVOLUTIONS

THE INTELLECTUAL AND PHILOSOPHICAL MOVEMENT KNOWN AS THE ENLIGHTENMENT, WITH ITS EMPHASIS ON REASON, INDIVIDUALISM, AND NATURAL RIGHTS, IS A CORNERSTONE OF THE 2008 WORLD HISTORY SOL. THE LASTING EFFECTS OF COLONIAL RULE ON THE POLITICAL AND ECONOMIC DEVELOPMENT OF AFRICA AND OTHER REGIONS ARE A KEY AREA OF STUDY.

WORLD WAR I AND ITS AFTERMATH

THE 2008 WORLD HISTORY SOL DEDICATES SIGNIFICANT ATTENTION TO WORLD WAR I, EXPLORING ITS COMPLEX CAUSES, INCLUDING MILITARISM, ALLIANCES, IMPERIALISM, AND NATIONALISM. SIMULTANEOUSLY, THE PROCESS OF DECOLONIZATION ACROSS ASIA AND AFRICA IS EXAMINED, AS NEWLY INDEPENDENT NATIONS SOUGHT TO ESTABLISH THEIR OWN IDENTITIES AND NAVIGATE THE COMPLEXITIES OF THE COLD WAR WORLD.

CONTEMPORARY WORLD ISSUES AND GLOBAL INTERDEPENDENCE

FREQUENTLY ASKED QUESTIONS

WHAT WAS THE PRIMARY CAUSE OF THE GLOBAL FINANCIAL CRISIS THAT BEGAN IN 2008?

THE PRIMARY CAUSE WAS THE COLLAPSE OF THE U.S. HOUSING MARKET, TRIGGERED BY THE SUBPRIME MORTGAGE CRISIS, LEADING TO A SEVERE CREDIT CRUNCH AND A DOMINO EFFECT ON FINANCIAL INSTITUTIONS WORLDWIDE.

WHICH INTERNATIONAL ORGANIZATION PLAYED A CRUCIAL ROLE IN COORDINATING RESPONSES TO THE 2008 FINANCIAL CRISIS?

THE INTERNATIONAL MONETARY FUND (IMF) AND THE G20 (GROUP OF TWENTY) PLAYED CRUCIAL ROLES IN COORDINATING INTERNATIONAL RESPONSES TO THE 2008 FINANCIAL CRISIS, FACILITATING COOPERATION AMONG LEADING ECONOMIES.
