PRIOR AND CURRENT INSURANCE INFORMATION

A CRITICAL COMPONENT OF THE ACORD 50 IS THE INQUIRY INTO THE APPLICANT'S PAST AND PRESENT INSURANCE COVERAGE. LOSS EXPERIENCE DATA

FILLABLE FIELDS OFTEN ALLOW FOR MORE TEXT THAN THEIR PAPER COUNTERPARTS, SO TAKE ADVANTAGE OF THIS TO PROVIDE COMPREHENSIVE INFORMATION. AMBIGUITY CAN LEAD TO UNDERWRITERS MAKING ASSUMPTIONS, WHICH MAY NOT BE IN THE APPLICANT'S FAVOR.

UTILIZE THE FILLABLE FEATURES

THE PRIMARY ADVANTAGE OF AN ACORD 50 FILLABLE FORM IS ITS INTERACTIVE NATURE. USE THE TAB KEY TO MOVE BETWEEN FIELDS, ENSURING YOU DON'T SKIP ANY. UNABLE TO TYPE IN FIELDS

IF YOU CAN OPEN THE FORM BUT ARE UNABLE TO TYPE IN THE FIELDS, IT MIGHT INDICATE THAT THE FORM WAS SAVED AS A FLATTENED PDF OR THAT SECURITY RESTRICTIONS ARE IN PLACE.
