This does not mean that the familiar names in the classical canon have to disappear. But they should be examined more critically for their continued importance, and additional theorists thus far neglected should complement them. Each chapter is organized as a debate between two theorists with contrasting views and approaches. At the end of each chapter, there is a critical evaluation of these political theorists' continued or renewed relevance.

Using anthropological sources and historical studies of European societies, she shows how property interest shaped often conflicted relations between parents and their children and among brothers, and yet it encouraged male charity toward sisters. Cox next considers how property transfer through adoption, guardianship, and remarriage, and the intervention of friends, concubines, and slaves, all contributed to expanding the boundaries of the household beyond kin.
