V izdajo ePravopisa 2018 so na novo uvedene slovarske iztočnice naslednjih problemskih sklopov: (1) »Pisna znamenja« (a) splošna znamenja (tilda, znamenja za odstotek, minuto, evro ...), (b) ločila (apostrof, dvopičje, klicaj, pomišljaj, vezaj), (c) znamenja v IT (afna, ključnik, lojtra, poševnica); (č) matematična znamenja (koren, plus, minus); (d) izpostavna znamenja (zvezdica); (2) »Poimenovanja praznikov, posebnih datumov, dnevov v tednu in mesecev« (tip veliki šmaren, pasha, štefanovo), (3) »Nazivi in naslovi ob imenu« (poklicni - odvetnik/odvetnica; akademski - redni profesor / redna profesorica; vojaški - generalmajor / generalmajorka; verski - pater, blaženi/blazena; protokolarni - visokost, eminenca; plemiški - car/carica; položajni - dekan/dekanja; glede na družbeni položaj - gospod, gospa); (4) »Imena pokrajin in otokov«, z njimi povezana prebivalska imena in pridevniki na -ski ter iz vseh sklopov izhajajoči svojilni pridevniki izpeljankami (Hercegovina, Hercegovec, Hercegovka, hercegovski). Pomembno dopolnilo pri redigiranju zemljepisnih imen je uvedba posebnega razdelka o predložni rabi v mestniku (Kje?), roditeljskem (Od kod?) in tožilniku (Kam?). S tem razdelkom so bila dopolnjena tudi vsa do sedaj vključena zemljepisna imena.
