The sense and intention of the author has not been altered at all, of course. We hope that Albert Howard would approve of this reworking of his book. His ideas are more important than ever. Wendell Berry wrote in *The Last Whole Earth Catalog* Howard's discoveries and methods, and their implications, are given in detail in *An Agricultural Testament*. They are of enormous usefulness to gardeners and farmers, and to anyone who may be interested in the history and the problems of land use.
