THIS ARTICLE CLARIFIES THAT THE LETTER OF CREDIT IS SEPARATE FROM THE UNDERLYING SALES CONTRACT. BANKS DEAL ONLY WITH DOCUMENTS, NOT GOODS OR SERVICES, WHICH LIMITS THEIR LIABILITY AND FOCUSES THEIR RESPONSIBILITIES ON DOCUMENT EXAMINATION.
