APPLICATION PROCESS FOR ASHP PSAP

REGISTRATION AND ACCOUNT SETUP

TO BEGIN THE APPLICATION PROCESS, PHARMACY STUDENTS MUST FIRST REGISTER FOR AN ACCOUNT ON THE ASHP PSAP PLATFORM.
