At the same time, benevolent work and rhetoric were vehicles for the emergence of a new middle-class identity, one which asserts virtue--not wealth--determined status. Ginzberg shows how a new generation that came of age during the 1850s and the Civil War developed new analyses of benevolence and reform. By post-bellum decades, the heirs of antebellum benevolence referred less to a mission of moral regeneration and far more to a responsibility to control the poor and vagrant, signaling the refashioning of the ideology of benevolence from one of gender to one of class. According to Ginzberg, these changing interpretations of benevolent work throughout the century not only signal an important transformation in women's activists' culture and politics but also illuminate the historical development of American class identity and of women's role in constructing social and political authority.

demale society: All Loves Excelling R. Pierce Beaver, 1998-10-30 Prior to 1800, mission societies had been composed exclusively of men. Then, on October 9 of that year, Miss Mary Webb gathered together fourteen Baptist and Congregational women and organized the Boston Female Society for Missionary Purposes. It would consist of . . . females who are disposed to contribute their mite towards so noble a design as diffusion of gospel light among the shades of darkness and superstition; dues were set at \$2.00 annually. So began a movement which was to spread throughout Massachusetts and, eventually, the entire country. Initially, however, progress was slow. Male prejudice opposed even the practice of women meeting together for prayer and contributing funds to mission work. And even after the role of women as fund-raisers was generally accepted there remained the reluctance of church mission boards to give to women a share in policy and decision making. Eventually the women organized their own missionary sending societies; these groups were largely responsible for sending single women into the mission fields - another practice which had long been opposed by denominational boards. R. Pierce Beaver traces the development of this fascinating movement, paying attention not only to its broad outlines, but also to the individual pioneers who led the way.

demale society: *A Passionate Usefulness* Gary D. Schmidt, 2004 In a literary environment dominated by men, the first American to earn a living as a writer and to establish a reputation on both sides of the Atlantic was, miraculously, a woman. Hannah Adams dared to enter--and in some ways was forced to enter--a sphere of literature that had, in eighteenth-century America, been solely a male province. Driven by poverty and necessity, and aided by an extraordinarily adept mind and keen sense of business, Adams authored works on New England history, sectarian history, and Jewish history, using and citing the most recent scholarly works being published in Great Britain and America. As a female writer, she would always remain something of an outsider, but her accomplishments did not by any means go unrecognized: embraced by the Boston intelligentsia and highly regarded throughout New England, Adams came to epitomize the possibility in a democratic society that anyone could rise to a circle of intellectual elites. In *A Passionate Usefulness*, the first book-length biography of this remarkable figure, Gary Schmidt focuses primarily on the intimate connection between Adams's reading and her own literary work. Hers is the story of incipient scholarship in the new nation, the story of a dependence that evolved into intellectual independence. Schmidt sets Adams's works in the context of her early poverty and desperate family situation, her decade-long feud with one of New England's most powerful Calvinist ministers, her alliance with the budding Unitarian movement in Boston, and her work establishing the first evangelical mission to Palestine (a task she accomplished virtually single-handedly). Today Adams still holds a place not only as a female writer who made her way economically in the book business before any other woman--or male writer--could do so, but also as a key figure in the transitional generation between the American Revolution and the Renaissance upon whose groundwork much of the country's later literature would build.

demale society: *The History of Mary Prince* Mary Prince, 2001-02-01 'I have been a slave - I have felt what a slave feels, and I know what a slave knows ...' Mary Prince recalls that in the slave market in Bermuda, where she was put up for sale, the buyers' talk 'fell like cayenne pepper into the fresh wounds of our hearts'. During her life as a slave she was taken from Bermuda to Turks Island and Antigua, eventually arriving in London where, in 1828, she reported the cruelty of her master and mistress to the Anti-Slavery Society. *The History of Mary Prince* (1831) was the first life of a black woman to be published in Britain. This extraordinary testament of ill-treatment and survival was a protest and a rallying-cry for emancipation that provoked two libel actions and ran into three editions in the year of its publication. This edition includes an introduction which discusses *The History* within the context of black writing, explanatory notes, a chronology, and supplementary material on enslavement and the case of Mary Prince.

demale society: Democratic Religion Gregory A. Wills, 2003-03-13 No American denomination identified itself more closely with the nation's democratic ideal than the Baptists. Most antebellum southern Baptist churches allowed women and slaves to vote on membership matters and preferred populists preachers who addressed their appeals to the common person. Paradoxically no denomination could wield religious authority as zealously as the Baptists. Between 1785 and 1860 they ritually excommunicated forty to fifty thousand church members in Georgia alone. Wills demonstrates how a denomination of freedom-loving individualists came to embrace an exclusivist spirituality--a spirituality that continues to shape Southern Baptist churches in contemporary conflicts between moderates who urge tolerance and conservatives who require belief in scriptural inerrancy. Wills's analysis advances our understanding of the interaction between democracy and religious authority, and will appeal to scholars of American religion, culture, and history, as well as to Baptist observers.
