Dans la lignée de nombreux travaux publiés ces dernières années, il est montré qu'il n'existe pas « une » ville coloniale, entité abstraite aux caractéristiques bien déterminées, mais il y a des villes dans des situations coloniales contrastées, dont leurs transformations ne furent ni similaires, ni linéaires, ni lisses. Les transformations urbaines ont résulté de processus complexes, produits par des acteurs nombreux (services centraux, municipalités, acteurs ordinaires européens ou indigènes, communautés religieuses, etc.) dont les logiques s'entremêlaient, parfois même concurrentes, et s'imbriquaient toujours les unes dans les autres en fonction de rapports de forces, certes inégaux, mais ô combien fluctuants. Cet ouvrage rappelle enfin que les transformations des villes maghrébines en situations coloniales sont le résultat d'une succession de projets, aboutis ou avortés, de contre-projets et de réalisations procédant, souvent, de hasards et, presque toujours, de bricolages incessants, ce qui donne à voir une réalité bien éloignée de l'image de la ville conquérante que se plaisait à véhiculer la propagande coloniale.
